The beautiful Murray River winds its way through much of the municipality and is a focal point for visitors and those who call the region home.







We commit to this journey to 2040 with you all.



#### Access, equity and inclusion

The community of Mildura Rural City Council believes everyone should have fair and equitable opportunity to live healthy, safe and happy lives.

We welcome and celebrate diversity and believe it fosters growth and strength.

We value the diverse range of identities, lifestyles and experiences of all members of our community, including people of all ages, abilities, cultural and linguistic backgrounds, gender, political perspectives and religious beliefs.

Inclusion and participation are key to building a strong community.

We are committed to preserving the dignity of all people and to ensure services, facilities and public spaces are openly inviting and fully accessible.

#### Gender equality to prevent family violence

Family violence is a significant issue in the Mildura Rural City Council community.

It affects women's wellbeing and prevents them from fully participating in society. It impacts individuals, families, workplaces, the community and the economy.

We recognise that gender equality can help prevent family violence and make our community safer and healthier.

We have zero tolerance for family violence and believe raising awareness and building respectful relationships is crucial to bring attitudinal and behavioural change.

In March 2020 Mildura Rural City Council declared a state of climate change emergency requiring urgent action by all levels of government.

Sustainability is about more than just our natural environment. We value sustainable development, sustainable communities and financial sustainability.

#### Art, culture, events and tourism

The Mildura region is enriched by our creative spirit and energised by our diverse community. Contrasting landscapes – from the Murray River to the Mallee outback and tight-knit country towns – make for an incredible cultural tapestry.

Situated on the traditional country of the Latji Latj Peoples, our history dates back over 40,000 years and we respect the deep and continuing connection Traditional Owners have to these lands and waters.

Much of Australia's fruit, vegetable, nut and cereal crops are grown in the region, therefore agriculture and horticulture are deeply entwined in local identity.

Local communities are deeply engaged in arts and cultural practices and experiences, and these are important to them. We acknowledge that arts, culture, events and tourism are transformative. They help to position towns as attractive places to live, work and invest. They help build identity and foster community connection.

There is incredible opportunity to use arts, events, tourism and culture as ways to improve wellbeing and encourage social connectedness, to contribute to the sustainability of the local economy and to showcase the character, diversity and heritage of our region.

We are committed to maintaining our reputation as a culturally unique and creative community. We will continue to celebrate our Indigenous history, many iconic natural wonders and picturesque locations through vibrant events, tourism, cultural and arts experiences.


# What is a Community Vision?

All Victorian councils are required to work in partnership with their communities to develop a Community Vision using deliberative engagement practices under the new Local Government Act (2020).

A Community Vision provides a long-term roadmap for the whole community, Council and other levels of government to partner together and create a future that enhances our region as a great place to live, work, play and visit. It highlights what the community values most and sets out long-term aspirations and key priorities.

Council will use the Community Vision to guide all planning, decision-making, programs, services and advocacy. The Vision is also legislated to guide Council in developing and implementing a Council Plan, Financial Plan, Community Health and Wellbeing Plan and an Asset Plan. The diagram below outlines the relationship between these documents and highlights the importance of the Community Vision as the peak of Council's integrated planning and reporting framework.

While Mildura Rural City Council has a custodial role in initiating, preparing, and maintaining the Community Vision on behalf of the local community, it is not wholly responsible for its implementation. Other partners, State and Federal Government, local organisations and the wider community – including business groups, not-for-profits and service providers – can also use the Community Vision, so everyone can work towards the same common goals for our region.





# Creating our Community Vision

In March 2021 Mildura Rural City Council launched Imagine 2040 – a major deliberative engagement process to consult with our community and together develop a new Community Vision.

In the midst of a global pandemic we asked our community to look ahead to the future and imagine what they want our community and region to be like in two decades time.

The sudden impact of COVID-19 and ongoing restrictions meant many scheduled face-to-face community discussions were unable to proceed. But despite this almost 2,000 who live, work, visit, study and play in the Mildura City Council area participated and contributed.

























# **Engaging with our community**

#### Phase 1, March – April 2021

Throughout March and April 2021 we conducted an extensive and broad engagement process to understand what our community's vision was for 2040. We asked people what they value most about our community, what challenges they face today, what would make it a better place by 2040 and what priorities we should focus on.

Council then worked alongside an independent social researcher to analyse and theme the feedback which was received through online and paper surveys, community events, facilitated conversations, illustration cards, an online visioning wall, vox pop interviews, social media and youth Minecraft challenge.


#### Phase 2, July 2021

The analysed community feedback was synthesised and used to generate Vision Statements and Goals under the five key themes of Environment, People, Place, Economy and Leadership. These Vision Statements and Goals were presented back to the community in July 2021 for further review and feedback.

This period of engagement provided a chance to check in, for community to look over how we had interpreted their input and let us know if anything wasn't right. Once again, our engagement process was challenged by the pandemic with the region's first confirmed cases of COVID-19 announced as the consultation launched.

#### Phase 3, August – September 2021

We again engaged an independent social researcher to analyse the community's feedback and work alongside us as we adjusted the Vision Statement and Goals to ensure they reflected the intent and aspirations of our community. The Draft Community Vision was then presented on public exhibition.

"I appreciate the important agriculture occurring in this region, but I am most impressed by (and most keen for) solar development, and sustainability and climate control measures."

community members find it very hard to express their needs when their English is limited - it is not that we don't have the knowledge or the understanding but it can be very frustrating and difficult to communicate what you want/ need."

"Lack of access to healthcare, the community is growing very quickly however the healthcare community is not. It's difficult to see a doctor when you need and is only getting harder. We are also starting to overflow in the schools."

"We need to promote our tourism and sporting facilities and make sure local businesses and industries are supported and contracted in the growth of our towns. Get local contractors before city based contractors! Grow our own, not have temporary citizens!"

"A stronger university that offers more options. Being able to retain more of our young people rather than so many leaving for study would be advantageous."

"I think Mildura needs tertiary education to keep more younger people in the community. I feel it lacks creative young people staying and adding to our overall offering. More students = more hospitality and entertainment = more tourism = better economy for everyone."

"More job opportunities particularly for people who don't speak good English. Most job interviews ask about your previous experience - its so hard to get experience, as we find it hard to get jobs. Work experience is not very highly regarded."

"I think Mildura needs to pick some industries in which to build our future around outside of agriculture. Is this solar, tourism, mining etc. We also need to do things that reduce costs not increase them. Our rates cannot continue to increase"

"Reduce rates. I pay double what a mate pays in Adelaide & his house is worth double mine."

"Challenge of not being able to advocate collectively, politically or powerfully enough as a region to attract government and private investment in our community."





# Measuring our progress

Developing a shared Community Vision is only the start of the journey. As our community works towards these desired outcomes, we will continually monitor and report on progress to ensure that we can celebrate what has been achieved and recognise what is still to be done.

#### How we will make this Vision a reality

The Community Vision will guide all of Council's planning and decision making and will be implemented through the Council Plan.

The Council Plan identifies medium-term goals and priority areas that will work towards the future desired outcomes identified by the community and outlined in the Vision.

Initiatives will be delivered through partnerships with a range of stakeholders including community groups, service providers, businesses and other levels of government.

Our Integrated Planning Framework ensures that all Council activities and financial resources are aligned to meet the aspirations, needs and expectations of the community.

We are committed to ongoing transparency and accountability with the community. We will prepare progress updates over the life of the 2040 Community Vision to celebrate achievements, recognise efforts, monitor trends and identify areas for future improvement.
